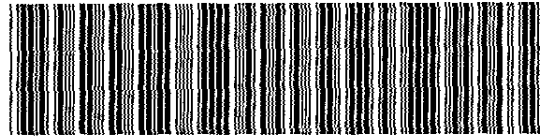

ARTICLE I

NAME

The name of this limited liability company is "RIGHT NOW SYSTEMS, LLC", referred to in these Articles of Organization as the "Company."
