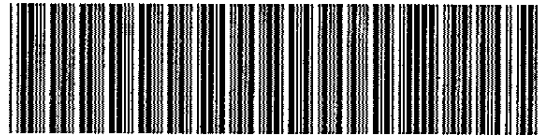

**FIRST:** The Articles of Organization were filed on MAY 28 2004 and assigned document number L04000040720.


**SECOND:** The following amendment(s) to the Articles of Organization was/were adopted by the limited liability company:
