ARTICLES OF ORGANIZATION

OF

MAYFLOWER OFFICE INVESTORS, LLC

THE UNDERSIGNED, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Florida Limited Liability Company (the "Company") under the laws of the State of Florida does set forth the following:

1. NAME The name of the Company is:

MAYFLOWER OFFICE INVESTORS, LLC

- 2. PERIOD OF DURATION In accordance with Section 608.409(1) of the Florida Limited Liability Company Act ("Act"), the term of existence shall begin the date these Articles are filed and its duration shall be perpetual, unless other dissolved or terminated by the unanimous written agreement of all members or pursuant to an event described in paragraph 7 of these Articles of Organization.
- 3. PURPOSE

 The purpose for which the Company is organized is solely limited to (I) owning, holding, selling, leasing, transferring, exchanging, operating and managing the property known as Mayflower Center, Inc., 222 South Westmonte Drive, Altamonte Springs, Florida (referred to herein as the "Property"), (II) entering into loan documents with Bank of America, N.A. (the "Lender") for the acquisition of the Property (the "Loan"), (iii) refinancing the subject property in connection with a permitted repayment of Lender's loan, and (iv) transacting any and all lawful business permitted by the laws of the State of Florida, nacessary and appropriate

to accomplish the foregoing. The Company shall have all of the powers vested in a Limited Liability Company organized and existing by virtue of such laws.

4, MAILING AND STREET ADDRESS OF COMPANY

- 6. ADMISSION OF ADDITIONAL MEMBERS Pursuant to Section 608,4232 of the Act, the Company may admit additional members upon the affirmative vote of a majority in interest of the members holding membership interests of the Company, either in attendance at a duly called meeting of the members at which a quorum exists or by written consent of the members of the Company. Any new member which is approved by the members of the Company as set forth herein shall become a member of the Company upon payment of the contribution to the capital of the Company as established from time to time by the members, and upon such member's agreement to comply with these Articles of Organization, its regulations or guidelines as the members may from time to time determine, in their sole discretion.
- 7. Upon death, retirement, resignation, expulsion, CONTINUITY OF BUSINESS bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company, the business of the Company shall be continued and the Company shall not be dissolved, unless the consent of all remaining members of the Company is obtained.

MANAGEMENT The Company is to be managed by a Manager. The 8. name and address of such Manager who is to serve as Manager until the first annual meeting of members or until its successors are elected and qualified is:

- CERTAIN ACTIONS REQUIRING UNANIMOUS VOTE: The unanimous vote of the 9. Company's Members shall be required in order to take any of the following actions:
 - A. Filling a petition or consent to a petition seeking reorganization, arrangement, adjustment, winding-up, dissolution, composition, liquidation or other relief on bahalf of the Company of its debts under any federal or state law relating to bankruptoy.
 - Seeking or consenting to the appointment of a receiver, liquidator, assignee, ₿. trustee, sequestrator, custodian or any similar official for the Company or a substantial portion of its properties,
 - C. Making any assignment for the benefit of the Company's creditors
 - Taking any action in furtherance of any of the foregoing. D.
- SEPARATENESS ("SPE") PROVISIONS: The Company shall not: 10.
 - merge into or consolidate with any other entity, or dissolve, terminate, liquidate in whole or in part, transfer or otherwise dispose of all or substantially all of its assets or change its legal structure;
 - b. fail to observe all organizational formalities, or fail to preserve its existence as an entity duly organized, validly extating and in good standing under the laws of Florida, or amend, modify, terminate or fail to comply with the provisions of its organizational documents;

- own any subsidiary, or make any investment in, any other entity;
- d. commingle its assets with the assets of any other entity;
- e. incur any debt, secured or unsecured, direct or contingent (including guaranteeing any obligation), other than (A) the loan from Lender, (B) trade and operational indebtedness incurred in the ordinary course of business with trade creditors, provided such indebtedness is (1) unsecured, (2) not evidenced by a note, (3) on commercially reasonable terms and conditions, and (4) due not more than sixty (60) days past the date incurred, and/or (C) financing leases and purchase money indebtedness incurred in the ordinary course of business relating to personal property at the subject. Property on commercially reasonable terms and conditions; provided however, the aggregate amount of the indebtedness described in (B) and (C) shall not exceed at any time three percent (3%) of the outstanding principal amount of the loan from Lender;
- f. fall to maintain its records, books of account, bank accounts, financial statements, accounting records and other entity documents separate and apart from those of any other entity;
- g. enter into any contract or agreement with any manager or member, or any affiliate of the foregoing, except upon terms and conditions that are intrinsically fair, commercially reasonable and substantially similar to those that would be available on an arm's-length basis with unaffiliated third parties;
- h. maintain its assets in such a manner that it will be costly or difficult to segregate, ascertain or identify its individual assets from those of any other entity:

- assume or guaranty the debts of any other entity, hold litself out to be responsible for the debts of any other entity, or otherwise piedge its assets for the benefit of any other entity or hold out its credit as being evailable to satisfy the obligations of any other antity;
- make any loans or advances to any entity; J.
- k. fail to file its own tax returns;
- ı. fall either to hold itself out to the public as a legal entity separate and distinct from any other entity or to conduct its business solely in its own name or fall to correct any known misunderstanding regarding its separate identity;
- fail to allocate shared expenses (including without limitation shared office space and services performed by an employee or an affiliate) among the entities sharing expenses and to use separate stationary, invoices and checks;
- n. fall to maintain adequate capital for the normal obligations reasonably foreseeable in a business of its size and character and in light of its contemplated business operations;
- ο. fail to remain solvent or pay its own liabilities (including, without limitation, salaries of its own employees) from its own funds; or
- acquire obligations or securities of its partners, members, shareholders or other affiliates, as applicable.
- RIGHT OF ASSIGNEE TO BECOME A MEMBER An assignee of a member's interest in the Company may become a member of the Company and acquire the rights and powers and be subject to the restrictions and liabilities of a member of the Company, upon the affirmative vote of a majority in Interest of the members holding membership interests of the Company (excluding the member seeking to

transfer his or her Interest in the Company) either in attendance at a duly called meeting of the members at which a quorum exists or by written consent of the members of the Company. The rights of the assignee shall be subject to the regulations, if any, and/or such other documents or agreements governing the operation of the Company as may be entered into from time to time, provided such assignment and admission of such assignee as a member complies with the terms and conditions of the regulations of the Company, if any and/or such other documents or agreements governing the operation of the Company as may be entered into from time to time.

- No member shall have the right to demand the **RETURN OF CAPITAL** 12. return of his or its contribution to capital except as provided in the Company's regulations or operating agreement, if any, then in existence, or after the securitization of the Loan only if the Borrower receives (I) confirmation from each of the applicable rating agencies that such amendment would not result in the qualification, withdrawal, or downgrade of any securities rating and (ii) approval of such amendment by the Lender or its assigns.
- AMENDMENT TO ARTICLES OF ORGANIZATION Except as restricted below. Members may adopt, atter, amend or repeal any provision of the Articles of the Organization upon the affirmative vote of a majority in interest of the members of the Company which vote is taken at a duly called meeting of the members at which a quorum is present, or by written consent of the members of the Company, or after the securitization of the Loan only if the Borrower receives (i) confirmation from each of the applicable rating agencies that such amendment would not result in the qualification, withdrawal or downgrade of any securities rating and (ii) approval of such amendment by the Lender or its essigns. Notwithstanding the foregoing, no

amendment to these Articles of Organization may amend Articles 3, 9, 10, 13, 14 or 16 without the written consent of Lender.

- 14. <u>CONSIDERATION OF INTERESTS OF CREDITORS.</u> The Company's members must be required to consider the interests of creditors in connection with any action subject to the vote of its members (including the SPE member), notwithstanding that the company may not then be insolvent.
- 15. <u>SUBORDINATION OF INDEMNIFICATION OBLIGATIONS</u>. The entity's obligation, if any, to indemnify its members or managers, is hereby fully subordinated to the Loan and the loan documents and shall not constitute a claim against it in the event that cash flow in excess of amounts necessary to pay holders of the loan is insufficient to pay euch obligations.
- 16. <u>SPE MEMBER.</u> At least one member of the Company must own 0.5% or greater membership interest and must be an SPE satisfying the general SPE requirements set forth above and the additional requirements set forth herein applicable to such member (i.e. corporate, limited partnership, or limited liability company requirements). In addition, each such member's Organizational Documents must provide for the following:
 - a. <u>Limited Purpose</u>. Such member's purpose must be limited to serving as a member in the Company.
 - b. Withdrawal of SPE Member. Upon the dissolution or withdrawal of the SPE Member from the Company, the Company must (i) appoint a new SPE Member, (ii) deliver an acceptable rating agency concerning, as applicable, the Company, the new SPE Member, and its owners, and (iii) obtain confirmation from the applicable rating agencies that the change in the SPE

Member will not result in a qualification, withdrawal or downgrade of any securities rating.

- CONTINUANCE OF COMPANY. If there is a death, dissolution or other 17. "termination event" of one or more members and at least one member remains, the Company shall not dissolve, and if any member is not an SPE, that the Company shall continue its existence (and not dissolve) for so long as a solvent member exits.
- REGULATIONS Pursuant to Section 608.423(1) of the Act, the members of the 18. Company may adopt, alter, amend or repeal regulations or any provision thereof, upon the affirmative vote of a majority in interest of the members of the Company in attendance at a meeting of the members duly called at which a quorum exists, or by written consent of the members of the Company. Such regulations shall comply with the provisions set forth herein.
