**ARTICLES OF ORGANIZATION**  
**OF**  
**SPORTSPLEX VILLAGE, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be **SPORTSPLEX VILLAGE LLC** ("Company").

**ARTICLE II**

**ADDRESS**

The mailing address and street address of the principal office of the Company shall be 4260 N.E. 35<sup>th</sup> Street, Ocala, Florida 34479.

**ARTICLE III**

**DURATION**

The Company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The Company's duration shall be perpetual unless the Company is earlier dissolved as provided in these articles of organization.

## ARTICLE V

### REGISTERED OFFICE AND AGENT

## ARTICLE VI

### CAPITAL CONTRIBUTIONS

The initial member of the Company shall contribute to the capital of the Company the sum of \$1,000.00.

A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.
