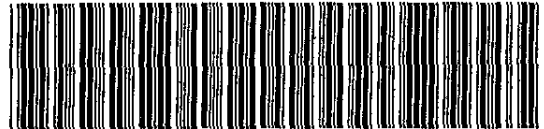

THE UNDERSIGNED, being authorized to execute and file these Articles of Organization, hereby certify that:

ARTICLE I - NAME

following:


- a. Upon written agreement of two-thirds of the Membership.




