Red Anders LLC

Please forgive my lack of understanding of this procedure.

Our company attempted to begin June 1, 2004.

Licenses and start up prevented us from conducting work until August of 2004.

Unfortunately Hurricane Charley made landfall over our home and business on Upper or North Captiva Island. We lived for 50 days without power, telephones and other services.

Until now the work conducted by Red Anders LLC has been to assist homeowners on the island with removal of debris and vegetation and interior work on the homes to minimize damage caused by the storm and progression of mold in particular.

There are three items, which I am uncertain of.

Box #4 - FEI has been applied for recently as Red Anders LLC has just received its occupational license from Lee County and is in the process of obtaining an additional license of finish carpentry. Until then, we were unaware that an additional FEI was required as opposed to just Red Anders' social security number, as there are no employees.

Box #5 - Is this to check on the status of the FEI application? If so an additional check of \$5.00 is enclosed.

Box #10- The physical address used in the initial application of incorporation listed an address where packages could be received but was not the physical address listed on the Lee County Occupational License. Upper or North Captiva Island (both Upper and North Captiva are used to describe or name the island) is an unbridged barrier island with no access to US Mail service. Access is only by boat. Therefore a PO Box is necessary for all business conducted by US Mail and for that fact any delivery system. Its zip code is erroneous but adopts that of Captiva Island, which does have mail service and is accessible by vehicle. The LLC uses a mail address of Sanibel where its PO Box is established.

We have changed the listing required by this Annual Report to reflect The L.L.C.'s physical address as it truly operates, but in fact even with IRS it must use a PO Box. We hope we have informed the Department of State Divisions of Corporations correctly in this regard. If we have made an error, please let us know. We apologize for any misrepresentation or lack of knowledge about appropriate procedure.
