ARTICLE I -- NAME

The mailing address and street address of the principal office of the Company shall be 9340 West Commercial Boulevard, Sunrise, Florida 33351.


ARTICLE III-- DURATION

#### ARTICLE VI -- TERMINATION OF EXISTENCE
