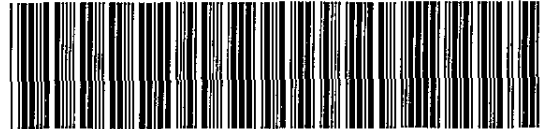

**ARTICLES OF ORGANIZATION**

**ARTICLE I - Name:**
