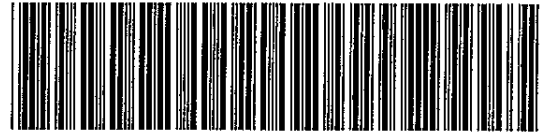

The undersigned natural persons, of the age of eighteen years or more, acting as organizers of a limited liability company under the State of Florida Limited Liability Company Act, now adopt these Articles of Organization for such limited liability company.

Article 1. Name of Limited Liability Company. The name of this limited liability company is Reperent Consulting, LLC (referred to herein as the "LLC").
