9. **Capital and Members:**

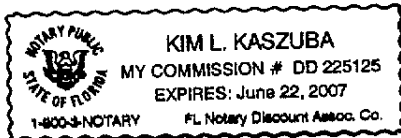




