

AMENDED & RESTATED OF ARTICLES OF ORGANIZATION

1. Name. The name of the limited liability company is Su Key 1, LLC.
2. Purpose. The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the State of Florida.
3. Address of Principle Office. The street address and mailing address of the principle office of the limited liability company is: Su Key 1, LLC, 5831 SW 60 Street, Miami, Florida 33143.
4. Term. The term of this LLC shall be perpetual.
5. Members at Time of Formation. There will be at least one member at the time the limited liability company is formed.
