Name

Admission of Additional Members



ARTICLE VII

Death Retirement, Resignation, Expulsion, Bankruptcy or Dissolution of a Member

The death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member, or the occurrence of any other event which terminates the continued membership of a Member in the Company, shall not dissolve the Company.
