Name**

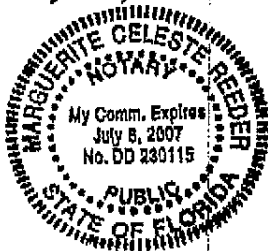



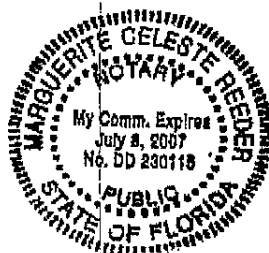
