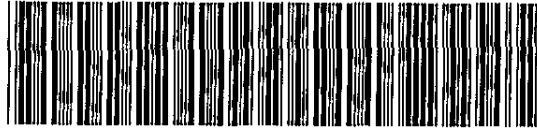

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE 1 - NAME**

The name of the limited liability company shall be **WEST COAST MARINE SERVICE LLC**, ("Company").

**ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 3380 Lucerne Terrace, Port Charlotte, Florida 33952 and the mailing address shall be the same.

#### **ARTICLE 5 - PURPOSES AND POWERS**
