ARTICLES OF ORGANIZATION OF RJM, LLC

ARTICLE I - NAME

The name of this Limited Liability Company is RJM, LLC.

ARTICLE II - ADDRESS AND PRINCIPAL PLACE OF BUSINESS

The mailing address of this Limited Liability Company is: 237 Chaucer Lane, Winter Haven, FL 33884, and the principal place of business for this company shall be: 237 Chaucer Lane, Winter Haven, FL 33884.

ARTICLE III - DURATION

The period of duration for the Limited Liability Company shall be perpetual ex unless sooner dissolved according to law.

ARTICLE IV - PURPOSES AND POWERS

To enter into and make all necessary contracts for its business with any person, entity, partnership, association, corporation, domestic or foreign, or of any domestic of foreign state, government, or governmental authority, or of any political or administrative subdivision, or department thereof, and to perform and carry out, assign, cancel, and rescind any of such contracts.
- or any of the purposes, enumerated herein otherwise granted or permitted by law, while acting as agent, nominee, or attorney-in-fact for any persons or corporations, and perform any service under contract or otherwise for any corporation, joint stock company, association, partnership, firm, syndicate, individual, or other entity, and in such capacity of under such arrangement to develop, improve, stabilize, strengthen, or extend the property and commercial interest thereof, and to aid, assist, or participate in any lawful enterprises in connection therewith or incidental to such agency, representation, or service, and to render any other service or assistance insofar as it lawfully may under the laws of the State of Florida, proving for the formation, rights, privileges and communities of limited liability companies for profit.
- 6.
