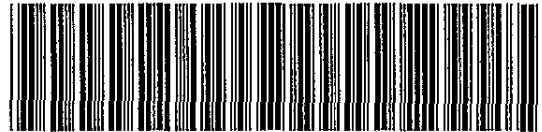

 - b.) To give Alexander Perez 10% interest in the company.

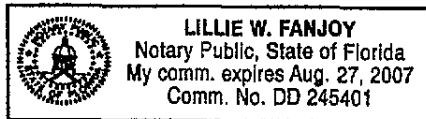


