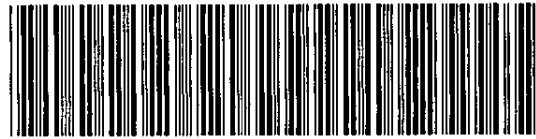

TO
THE ARTICLES OF ORGANIZATION OF

The undersigned sole member of Lightship Asia Pacific, L.L.C.
