## ARTICLES OF ORGANIZATION OF TBC MANAGEMENT, L.L.C.

ACCEPTANCE OF SHAPE O The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I - NAME
