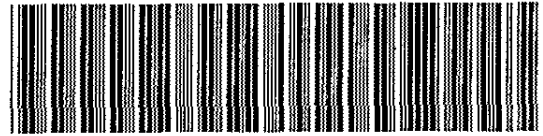

**ARTICLE IX.**


