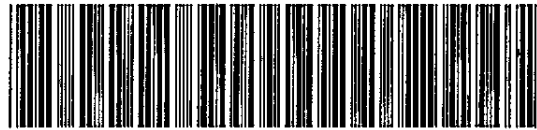

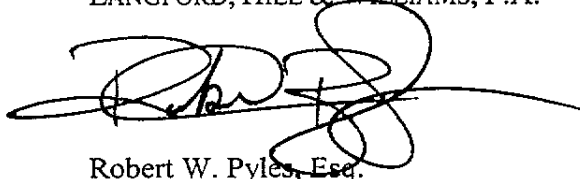

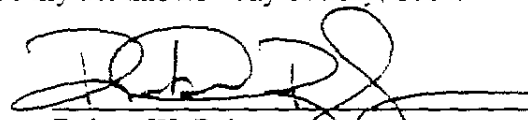
**ARTICLE V — Term:**
