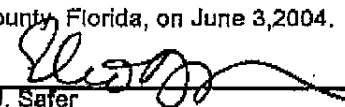
ARTICLE IV - MANAGEMENT

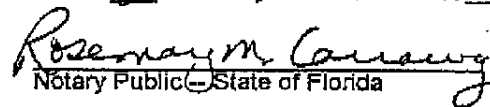
