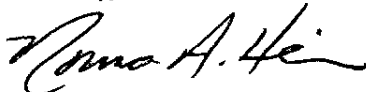

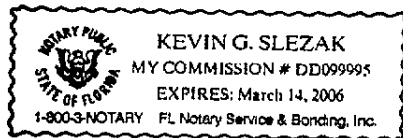

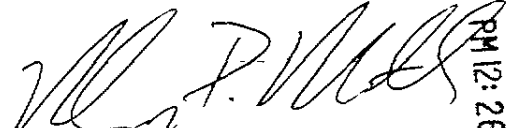
**CERTIFICATE DESIGNATING REGISTERED AGENT
