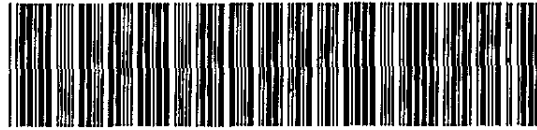

ARTICLES OF ORGANIZATION

OF

GLOBAL SERVICE DEVELOPMENT, LLC (A FLORIDA LIMITED LIABILITY COMPANY)

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 – NAME


