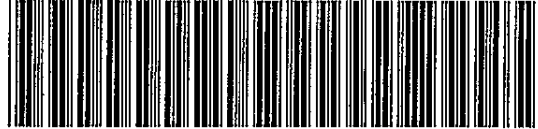



ARTICLE I
NAME

The name of this Limited Liability Company shall be SDI OF HAINES CITY, LLC.

ARTICLE II
PURPOSE

This Limited Liability Company shall exist perpetually from the date of filing with the Secretary of State of the State of Florida.

ARTICLE III
PURPOSE

Provided, however, that no member may transfer, assign or pledge any membership interest without the prior, written consent of Sonic Industries, Inc.
