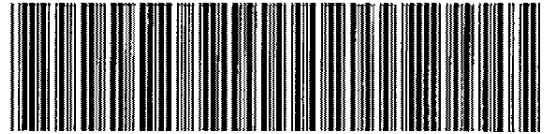

# **ARTICLES OF ORGANIZATION**

#### **ARTICLE 1 - NAME**
