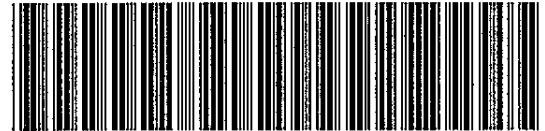

ARTICLES OF ORGANIZATION
OF
FLORIDA AFFORDABLE LEGAL SERVICE, P.L.

The undersigned incorporator desiring to form a Professional Limited Liability Company in accordance with Chapter 608 of the Florida Statutes, adopts the following Articles of Organization:

ARTICLE ONE
NAME

The name of the Professional Limited Liability Company shall be:

ARTICLE THREE
PURPOSE

The purpose for which the Professional Limited Liability Company is organized shall be to engage in any activity or business permitted under the laws of the United States, of this State, and of any other lawful jurisdiction such as:

- A. Specifically to engage in every phase and aspect of the practice of law and to render professional legal services to any and all persons, firms, corporations, and other entities, and to the general public, in the State of Florida and all its political subdivisions and in every jurisdiction, Federal and State, and before all courts and public and administrative bodies and otherwise, throughout the world, unless prohibited by law.
- B. To invest its funds in real estate, mortgages, stocks, bonds, or other types of investments, and to own real or personal property necessary for the rendering of the aforesaid professional services.
- C. To take, acquire, rent, buy, hold, own, maintain, work, develop, sell, convey, lease, mortgage, exchange, improve, construct, erect, build, equip, repair, improve and otherwise deal in, manage and dispose of real estate and real property (including but not limited to houses, commercial properties, apartment houses, hotels and motels, and the operation thereof, and the leasing of rooms or apartments therein, both furnished and unfurnished), streets, sidewalks, reservoirs, water works, sewers, docks, fills subdivisions, and all other kinds of property of whatsoever nature, whether real, personal or mixed, or any interests or rights therein without limits as to amounts; to buy, sell, assign, convey, and cancel liens upon personal property and real estate of every kind and nature whatsoever; to draw, accept, endorse exchange, promissory notes, bonds, debentures, and other negotiable instruments or whatsoever nature, and to secure the same by mortgage on its property or otherwise; to issue on commission, subscribe for, take, acquire, hold, exchange, and deal in shares, stocks, bonds, obligations, or securities of any government or authority, individual or corporation.
- D. To invest the Professional Limited Liability Company's assets for the benefit of the company's employees, including but not limited to the parties hereto, which benefits are allowable to Professional Limited Liability Company's in general under the Internal Revenue Code.
- E. To conduct its business at multiple locations, have one or more offices at multiple locations, and buy, hold, mortgage, sell, convey, lease otherwise dispose of real and personal property in the State of Florida, as well as in the District of Columbia, all other states, territories, possessions and dependencies of the United State, and all other countries or places whatsoever.
- F. To contract debts and borrow money.
- G. This Professional Limited Liability shall not engage in any business other than the rendering of legal services for which it is to be specifically formed, provided, however, that this limitation shall not act to prohibit such company from investing its funds in real estate, mortgages, stocks, bonds, or other type of investments, or from owning real or personal property incidental for the rendering of said professional services.
- I. The Professional Limited Liability Company, subject to any limitations provided in any statutes of this State, shall have the power, in furtherance of its company purposes to be a partner, member, or associate or other business enterprises or ventures.

- J. To have and exercise all rights and powers from time to time granted to a Professional Limited Liability Company by law.
- K. All of the above purpose clauses shall not be limited by reference to or inference from one another, but each such purpose clause shall be construed as a separate statement conferring independent purposes and powers upon the company.

**ARTICLE SEVEN
AMENDMENT OF ARTICLES**

The Professional Limited Liability Company reserves the right to amend these Articles of Organization at any time in a manner now or subsequently permitted by statute. Any change authorized by the members entitling them to exercise a majority of the voting power of the Professional Limited Liability Company, or any greater number that may then be required by statute, shall be binding and conclusive on every member of the Professional Limited Liability Company as fully as if each unit holder had voted for the change. No member, notwithstanding that he or she may have voted against the amendment or may have objected in writing, shall be entitled to payment of the fair cash value of his or her shares or any other rights of a dissenting member.

Every amendment shall be approved by the managers, proposed by them to the members, and approved at a managers' meeting by a majority of the unit entitled to vote thereon, unless all the managers and all the members sign a statement manifesting their intention that a certain amendment of these Articles of Organization be made.
