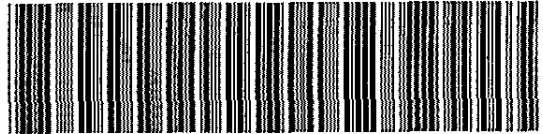

The undersigned being all the Managers and Members of Sun Alliance Management of South Florida, LLC (hereinafter referred to as the "Company"), hereby take the following action:

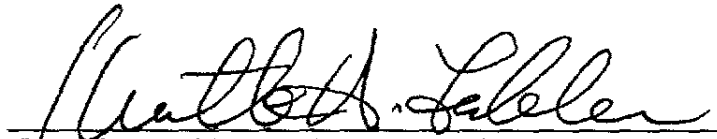
RESOLVED, due to resignation, the Company hereby removes Kenneth A. Feldman as a manager and member of the Company.
