**ARTICLES OF ORGANIZATION**  
**OF**  
**VIP MEDICAL SUPPLIES, LLC**  
**A Florida Limited Liability Company**

The undersigned, acting as the members of a limited liability company under the Florida Limited Liability Company Act as set forth in Chapter 608 of the Florida Statutes, does hereby adopt the following Articles of Organization for VIP MEDICAL SUPPLIES, LLC (the "Company"):

**ARTICLE I**

**NAME**

The name of the Company is VIP MEDICAL SUPPLIES, LLC and its principal place of business shall be in the City of Deerfield Beach, County of Broward, State of Florida, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

**ARTICLE II**

**DURATION**

The limited liability company shall exist until dissolved in a manner provided by law, or as provided in accordance with the regulations adopted by the Members.

#### ARTICLE FOUR

##### INITIAL REGISTERED OFFICE AND AGENT

#### ARTICLE FIVE

##### MANAGEMENT

The Company is to be managed by one or more managers and is, therefore, a manager - managed company.

#### ARTICLE SIX

##### INDEMNIFICATION

The Company shall reimburse each person for all costs and expenses, including, without limitation, attorneys' fees, reasonably incurred by him/her in connection with any such liability in the manner provided for by law or in accordance with the regulations of the Company. The rights accruing to any person under the foregoing provision shall not exclude any other right to which he/she may be lawfully entitled, nor shall anything therein contain or restrict the right of the Company to indemnify or reimburse such person in any proper case even though not specifically provided for herein.

The undersigned, in accordance with Section 608.407(3), being one of the original members of the Company, hereby certifies that the foregoing constitutes the proposed Articles of Organization of VIP MEDICAL SUPPLIES, LLC.
