(d) Make contracts or guarantees or incur liabilities; borrow money at such rates of

proceeding, whether civil or criminal, in which he or it is made a party.

(1) Have and exercise all powers necessary or convenient to effect any or all of the

purposes for which the limited liability company is organized.
