

ARTICLES OF ORGANIZATION OF S&P FAMILY FARMS, L.I

The undersigned, being authorized to execute and file these Articles, hereby certified

ARTICLE I - Name:

The name of the limited liability company is S&P Family Farms, L.L.C. (the "Company is S&P Family Farms, L.L.C.)
