

## ARTICLES OF ORGANIZATION

OF

#### FLORIDA FITZPATRICK, LLC

- 1. Name. The name of this limited liability company is Florida Fitzpatrick, LLC, a Florida limited liability company (the "Company").
- 2. <u>Duration</u>. The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State
