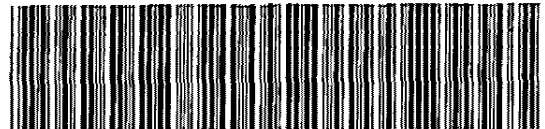



**ARTICLES OF ORGANIZATION
OF
SHELDON SUNSET, LLC**

1. **NAME.** The name of this limited liability company is SHELDON SUNSET, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.




