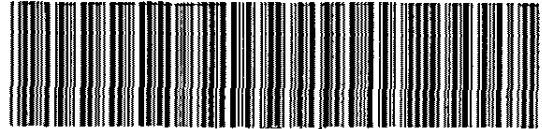

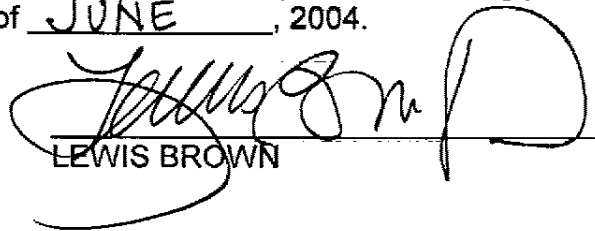
5. Additional Members. The members may admit such additional members on such terms and conditions as they may unanimously agree.

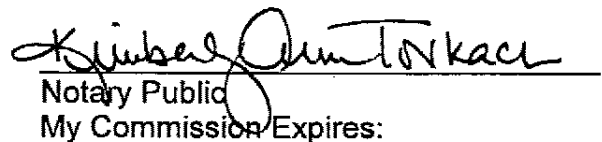
