**ARTICLES OF ORGANIZATION
OF
VALCOM REALTY L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be VALCOM REALTY L.L.C. (the "Company").

ARTICLE II -- ADDRESS

The street address and mailing address of the initial principal office of the Company shall be 5801 Pelican Bay Blvd., Suite 300, Naples, Florida 34108.

ARTICLE III -- DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization or in the Company's Operating Agreement.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

The name and street address of the initial registered agent and registered office of the Company in the State of Florida are: Joshua M. Bialek, Esquire, Porter, Wright, Morris & Arthur LLP, 5801 Pelican Bay Blvd., Ste. 300, Naples, Florida 34108.

ARTICLE V -- MANAGEMENT

The Company shall be managed by a Manager in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company. A member of the Company may serve as the Manager. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. The Company's initial Manager is David Greenlee.

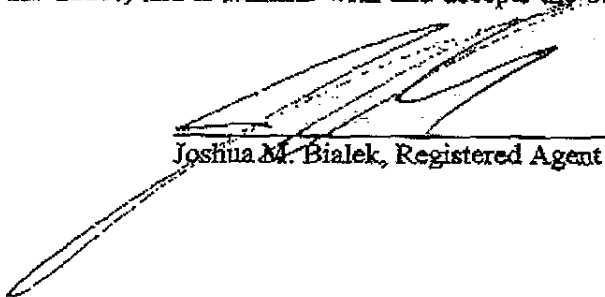
