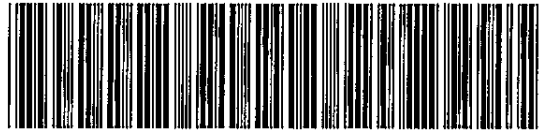

ARTICLES OF ORGANIZATION
OF
PRECISION STRUCTURES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, at Chapter 608, Florida statutes, hereby makes, acknowledges, and files, the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be Precision Structures, LLC ("Company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the Limited Liability Company is 11812 94th Street, North, Largo, Florida 33773.

ARTICLE III -- DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these articles of organization.
