**ARTICLES OF ORGANIZATION
FOR

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, acting as the organizer of Grindle Park, LLC, under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is:

**ARTICLE II
INITIAL REGISTERED AGENT, REGISTERED OFFICE ADDRESS**
