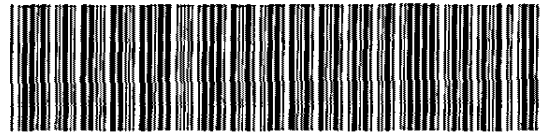



ARTICLES OF ORGANIZATION
902 W. LAKE SHORE DRIVE, LLC


