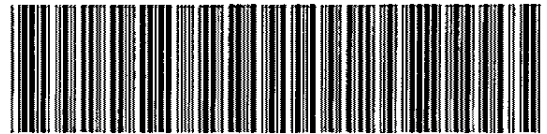

**ARTICLES OF ORGANIZATION
