ARTICLE IV - Management



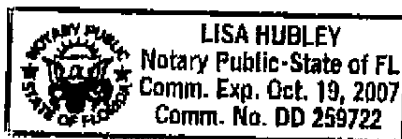
