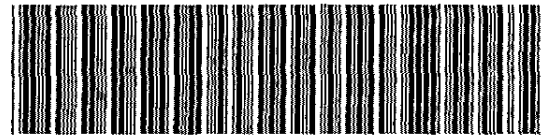


Article X- Management- Is hereby amended as follows:
