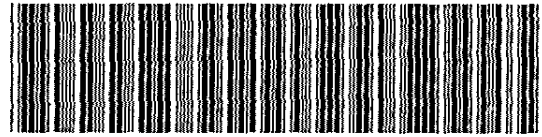

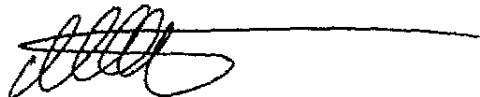

The Limited Liability Company is to be managed by a manager or managers and is, therefore, a manager-managed company.

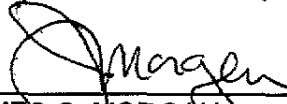

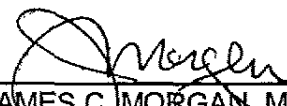
Article VI
