**ARTICLES OF ORGANIZATION
OF

The undersigned, a representative of the members of Tampa Investor Group, LLC, a Florida limited liability company (the "Company") under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby submit the following Articles of Organization:

ARTICLE I

Name

The name of this Limited Liability Company is Tampa Investor Group, LLC (the "Company").

ARTICLE II

Address

ARTICLE III
