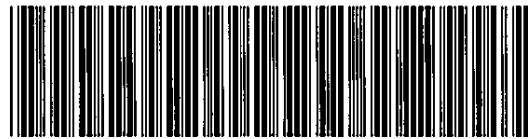

The undersigned, sole Member of SDR, LLC, a Florida limited liability company (the "Company") and desiring to amend the Articles of Organization of the Company pursuant to the terms of Chapter 608, Florida Statutes, the Florida Limited Liability Company Act (the "Act"), states as follows:

1. The current name of the Company is SDR, LLC.
2. The date of the filing of the original Articles of Organization of the Company is June 15, 2005, which articles were amended pursuant to the filing of Articles of Amendment to the Articles of Organization filed on June, 29, 2004, which articles were further amended pursuant to the filing of Articles of Amendment to the Articles of Organization filed on July 9, 2004 (altogether hereinafter, the "Articles of Organization").
3. The Articles of Organization of the Company are hereby amended by deleting Article I in its entirety and inserting the following section in its place and stead:

**ARTICLE I - NAME**

"The name of the limited liability company shall be: SDR AIR, LLC."

4. This amendment to the Articles of Organization of the Company was approved by the consent of the sole member of the Company on July 9, 2007.
