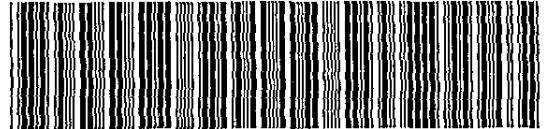



ARTICLES OF ORGANIZATION

OF
