#### ARTICLES OF ORGANIZATION OF

#### SHOPS AT US1, LLC

### ARTICLE I

The name of this Limited Liability Company shall be <u>SHOPS AT US1, LLC</u> (the "Company").

### ARTICLE || DURATION
