# ARTICLES OF ORGANIZATION FILED

#### CIRCLE L HOLDINGS OF MANATEE COUNTY, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make: acknowledge; and file the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be CIRCLE L HOLDINGS OF MANATEE COUNTY, LLC, ("Limited Liability Company").

#### ARTICLE II - DURATION

This Limited Liability Company shall commence its existence on the date of filing these Articles of Organization and shall exist perpetually thereafter unless sooner dissolved according to law.

To enter into and make all contracts for any of its businesses or activities deemed necessary and appropriate but not contrary to law with any person, entity, partnership, association, corporation, domestic or foreign, or of any domestic or foreign state, government, or governmental authority, or of any political or administrative subdivision, or department thereof, and to

perform and carry out, assign, cancel, modify, terminate, amend or rescind LED any of such contracts.

- To exercise all or any of the Limited Liability Company powers, and to carry out all or any of the purposes, enumerated herein otherwise granted any of STATE or permitted by law, while acting as agent, nominee, or attorney-in-fact for SEE.
