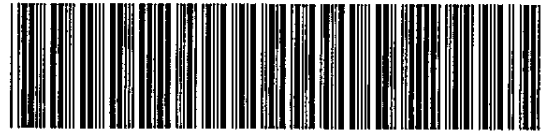


FIRST: The Articles of Organization were filed on June 17, 2004 and assigned
