ARTICLE I: NAME AND ADDRESS

The name of the limited liability company is **M & P Enterprises, LLC**. The initial mailing address and street address of the principal office of the limited liability company is 2990 U.S. Hwy 301 N., Ellenton, FL 34222.

ARTICLE II: PURPOSE AND POWERS

The purpose and powers of this limited liability company is to engage in any activity or business authorized under the Florida Statutes.

ARTICLE III: DURATION

The term of duration for the limited liability company shall begin upon filing these articles of organization with the Florida Department of State and shall expire on December 31, 2053.

ARTICLE IV: MANAGEMENT

ARTICLE V: ADMISSION OF ADDITIONAL MEMBERS

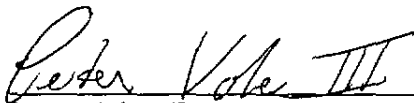
