#### ARTICLES OF ORGANIZATION

THE UNDERSIGNED, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges and filed the following Articles of Organization:

#### <u>ARTICLE I - NAME</u>

All references in these Articles of Organization to "manager," "officer," "employee" and "agent" shall include their heirs, estates, executors, administrators and personal representatives of such persons.
