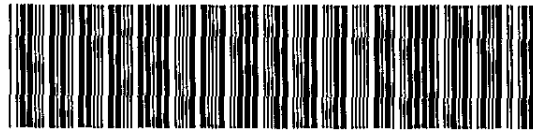

The undersigned, being authorized to execute and file these Articles, hereby certifies that:

ARTICLE I — Name:

Article VII— Member's Right to Continue Business


